**Quotes:**

- Official GSA quotes are provided for products that are currently awarded on the contract and Included under SIN 33721 - Furniture
- Products not awarded on the contract are considered Open Market and must be identified that way on that line item of the quote.

**Purchase Orders:**

- Purchase Orders should be made out to Versteel, or Versteel C/O Dealer. These are direct End User orders and will be billed by Versteel with the customer
- Orders may also be received through Commercial 3<sup>rd</sup> Parties that are eligible to use GSA contractors and could include Dealers in Good Standing with Versteel, Federal Contractors or GSA Package companies working on behalf of an Eligible Federal Entity.
- These orders must be accompanied by a copy of the Eligible Customers original PO as well as a document authorizing the GSA purchase. Acceptable documentation includes:
  - ♦ Contractor Teaming Agreement Letter
  - ♦ Letter of Authorization from the Govt Customer
- Versteel & Dealer quotes must accompany PO's.
- All PO's must clearly state “GSA – GS-28F-0008S”.
